As of May 25, 2021, the Nelnet contract has not been signed, agreements from both parties (Nelnet and NDUS) are very close to an agreement with anticipated approve early next week. Since this is a time sensitive project with the current payment application contract expiring next summer, 2022, both the CTS and Nelnet teams made a decision to continue with the planning of the project without a signed contract.

Both NDSU and UND have volunteered to pilot Quikpay the first solution to be implemented. Quikpay includes payments and billing. Both campuses meet with CTS and Nelnet weekly to identify work completed, what the next steps are etc.

CTS has completed the install to the DEV environment and continue to migrate through TEST and then STG, where users will begin conducting user acceptance testing (UAT). Testing is scheduled for the week of June 17, 2021. Tentative go-live is not until after fall term begins.

Both MiSU and NDSU have volunteered to pilot the Storefront project. They will have a kickoff to begin identifying the next steps to the implementation. Quikpay is not a dependency for the rollout of Storefront, therefore, running both projects in parallel will provide benefits and value to the overall project and continue to keep campuses engaged.
