EXECUTIVE SUMMARY

In previous status reports the health of the project reported as "behind" schedule based on two of the three components (Quikpay and Commerce Manager). Now that we have added the storefront component to the overall schedule, we are reporting that the health of the project is on schedule and forecasted to stay on track.

Quikpay: Overall, NDSU and UND continue testing payments and reviewing the eBill look and feel. CTS migrated a development up to the STAGE environment for user acceptance testing. The development added custom buttons allowing students that have multiple bills at different institutions to make a payment at that specific school.

- Deposits/Prepayments: Nelnet completed the development work needed for students to make
 deposits to their account that are applied to specific charges. During testing, NDSU and UND are
 finding that those deposits are netting against the total charges and that is not the desired outcome.
 Nelnet continues to work through the issue and confident they will find a solution to the issue.
- **eBill:** Campuses continue to review the look and feel of the eBill. They have submitted suggested changes to their format and Nelnet is working to making those changes. The CTS development team is currently working on extracting data from PeopleSoft and placing it into the Nelnet bill file spec.

Commerce Manager: Both the Nelnet and NDUS teams continue to work through the list of third-party vendors and prioritize work that is needed. As the teams work with individual vendors, they are finding the work is unique, challenging, and some are not willing to integrate with Nelnet, example Handshake. Discussions continue with the campuses to find alternative solutions for those not willing to integrate with Nelnet, while others like T2 are making code changes to accommodate the new payment system.

- **T2 (Parking):** Intake form complete by Nelnet and sent to T2. T2 will begin making code changes to accommodate the Nelnet payment application. Nelnet will gather requirements from the campuses to begin the work needed for the install. There are five campuses that currently use T2.
- TargetX: Both NDSU and UND have requested a project to TargetX to begin discussion around moving from the current payment application to Nelnet. A meeting is scheduled with all parties to identify the work needed, timeline, and who needs to do what. NDSU and UND are the only two campuses that use this application.

*Other third-party applications are in the queue to begin work.

Payment Plan Schools (DSU, MaSU, and WSC): An initial kick off meeting was held to review the payment plan component of the project. All three campuses are currently working on a requirements document around how they conduct payment plans in the current system. This information will assist the Nelnet team with configuration to the new system. In addition, all three campuses need to provide a completed bank letter.

Storefront:

- MiSU is in the stage of finalizing products and completing user acceptance testing (UAT). They have mapped GL codes to all products. MiSU is on target to go live with their store sometime in September, all depends on UAT.
- NDSU finalized GRHC (Germans from Russia Heritage Collection) library content and loaded product GL codes. NDSU is working to fix some links in their store and address some additional issues. They are also reviewing examples of packing slips and need to supply any suggestions to Nelnet. Other items on their list of "to do's" is gathering tax rates from five states with NDSU tax nexus.
- NDUS/CTS established NDIT MoveIT connection and provided the SSH Public Key and successfully
 tested a connection (this is to securely move data). Nelnet is confirming that the existing connector
 instance that is being used for Quikpay can be pointed to a second database (Financials) without
 needing to install a second connector.

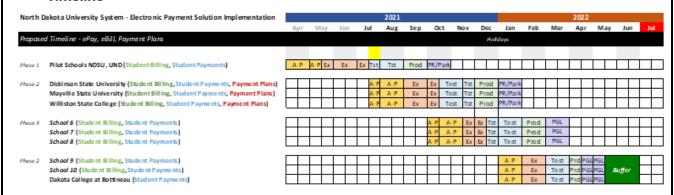
